1 MR. MEAGHER: Good afternoon. My name is  
2 Joseph Meagher and I am counsel to the  
3 Broome County Industrial Development Agency.  
4 The Agency is conducting a hearing pursuant to  
5 General Municipal Law Section 859A to seek  
6 public comment on an application for financial  
7 assistance submitted by ADEC Solutions USA,  
8 Inc., in connection with the proposed document  
9 management facility to be located at 56 Broome  
10 Corporate Parkway in the Town of Conklin.

11 The acceptance of the filing by the  
12 Agency does not infer any position on the  
13 approval or disapproval of the financial  
14 assistance requested. No position will be  
15 taken by the Agency until the public hearing  
16 is concluded.

17 A copy of the application, along with the  
18 cost benefit analysis prepared by the Agency,  
19 is available for your review at the offices of  
20 the Agency.

21 Notice of this hearing was published in  
22 the Press & Sun Bulletin on June 23rd, 2015.  
23 I request that each person wishing to speak  
24 state his or her name, and if you are speaking  
25 on behalf of an entity or organization, please

1 identify that entity or organization. The  
2 hearing will remain open until all public  
3 comment is concluded.

4 I will first ask Kevin McLaughlin,  
5 Executive Director of the Agency, to explain  
6 the benefits that have been requested by  
7 ADEC Solutions USA, Inc.

8 MR. McLAUGHLIN: Thank you, Joe.

9 The project entails the acquisition and  
10 rehabilitation of 56 Broome Corporate Parkway  
11 by ADEC Solutions USA.

12 ADEC Solutions is a global business  
13 process outsourcing company with offices  
14 throughout the world including United Kingdom,  
15 Australia, Singapore and the Philippines, to  
16 name a few. Their clients include companies  
17 in the fields of healthcare, banking, media  
18 and entertainment, aerospace, legal,  
19 human resources and housing.

20 Initially, the 56 Broome Corporate  
21 Parkway site will serve as a center for  
22 document management solutions including  
23 scanning and archiving services.

24 The company expects to hire 133 employees  
25 in the next two years with expectations of

1 growing to over 250 in three to five years.  
2 The total project cost for the project,  
3 including acquisition of the building, is  
4 estimated at \$920,000.

5 The BC -- the Agency will be considering  
6 approving a standard 15-year PILOT for the  
7 company including sales and management tax  
8 exemptions.

9 Thank you.

10 MR. MEAGHER: All right. Does anyone  
11 wish to be heard either for or against the  
12 application?

13 I will ask again, does anyone wish to be  
14 heard either for or against the application?

15 One last time, since we have a new person  
16 in the audience, does anyone wish to be  
17 heard --

18 MR. FINCH: I'm not a new person but  
19 that's okay. No. I don't have any comments.

20 MR. MEAGHER: All right. Since there's  
21 no public comment, I'm going to draw the  
22 hearing to a conclusion.
