

A regular meeting of Broome County Industrial Development Agency (the "Agency") was convened in public session at the offices of the Broome County Public Library in the City of Binghamton, Broome County, New York on Friday, December 11, 2015 at 12:00 o'clock p.m., local time.

The following resolution was offered by Mr. Stevens, seconded by Mr. Howard, to wit:

RESOLUTION AUTHORIZING A CERTAIN LEASE/LEASEBACK TRANSACTION TO FACILITATE THE FINANCING OF THE RENOVATION AND EQUIPPING OF AN EXISTING 131,774 SQUARE FOOT, 148 UNIT APARTMENT TOWER LOCATED IN THE CITY OF BINGHAMTON, BROOME COUNTY, NEW YORK, TO BE USED SUBJECT TO A SECTION 8 HOUSING ASSISTANCE PROGRAM CONTRACT COVERING 147 OF THE 148 UNITS (THE "FACILITY"), APPOINTING POLYMAR HOUSING SPE, LLC AND WE'LL DO IT LIVE SPE, LLC (COLLECTIVELY, THE "COMPANY") AS THE AGENT(S) FOR THE PURPOSE OF THE RENOVATION, EQUIPPING AND LEASING OF THE FACILITY AND AUTHORIZING THE EXECUTION AND DELIVERY OF A PAYMENT-IN-LIEU-OF-TAX AGREEMENT ("PILOT") DEVIATING FROM THE BROOME COUNTY INDUSTRIAL DEVELOPMENT AGENCY'S UNIFORM TAX EXEMPT POLICY AND AUTHORIZING THE EXECUTION AND DELIVERY OF CERTAIN DOCUMENTS WITH RESPECT THERETO.

WHEREAS, the Broome County Industrial Development Agency (the "Agency") is authorized and empowered by the provisions of Chapter 1030 of 1969 Laws of New York, constituting Title 1 of Article 18-A of the General Municipal Law, Chapter 24 of the

Consolidated Laws of New York, as amended (the "Enabling Act") and Chapter 564 of the 1970 Laws of New York, as amended by Chapter 402 of the 1987 Laws of the State of New York, constituting Section 895-a of said General Municipal Law (said Chapter and the Enabling Act being hereinafter collectively referred to as the "Act") to promote, develop, encourage and assist in the acquiring, constructing, reconstructing, improving, maintaining, equipping and furnishing of industrial, manufacturing, warehousing, commercial, research, recreation and civic facilities, among others, for the purpose of promoting, attracting and developing economically sound commerce and industry to advance the job opportunities, health, general prosperity and economic welfare of the people of the State of New York, to improve their prosperity and standard of living, and to prevent unemployment and economic deterioration; and

WHEREAS, to accomplish its stated purposes, the Agency is authorized and empowered under the Act to acquire, construct, reconstruct and install one or more "projects" (as defined in the Act), or to cause said projects to be acquired, constructed, reconstructed and installed, and to convey said projects or to lease said projects with the obligation to purchase; and

WHEREAS, Polymar Housing SPE, LLC and We'll Do It Live SPE, LLC (collectively, the "Company") have presented an application (the "Application") to the Broome County Industrial Development Agency (the "Agency"), a copy of which was presented at this meeting and copies of which are on file at the office of the Agency, requesting that the Agency consider undertaking a project (the "Project") consisting of the following: (A) (1) the acquisition of a 2.32 acre parcel containing an existing eleven (11) story, 148 unit apartment tower designated for elderly residents which is subject to a Section 8 Housing Assistance Program Contract covering 147 of the 148 units and located in the City of Binghamton, Broome County, New York (the "Land"), (2) the renovation of the eleven (11) story apartment tower containing gross building space of 131,774 square feet and consisting of 147 one (1) bedroom, one (1) bathroom units measuring approximately 600 square feet each and 1 two (2) bedroom, one (1) bathroom unit measuring approximately 900 square feet. In addition, there is a commercial kitchen for resident use, a large dining room, and various common area amenities throughout the apartment tower (the "Facility"); and (3) the possible acquisition and installation therein and thereon of certain machinery and equipment (the "Equipment") (the Land, the Facility and the Equipment being hereinafter collectively referred to as the "Project"), all of the foregoing to be leased by the Company as a 148 unit apartment tower designated for elderly residents and any other directly or indirectly related activities; (B) the granting of certain "financial assistance" (within the meaning of Section 854(14) of the Act) with respect to the foregoing, including certain exemptions from mortgage recording taxes and real estate taxes (collectively, the "Financial Assistance"); and (C) the lease (with an obligation to purchase) or sale of the Project to the Company or such other person or entity as may be designated by the Company and agreed upon by the Agency; and

WHEREAS, in compliance with the provisions of Section 859-a of the Act, the undertakings of the Agency are contingent upon the Agency making a determination to proceed with the Project following compliance by the Agency with the public notice and public hearing requirements set forth in Section 859-a of the Act; and

WHEREAS, the Executive Director of the Agency (A) caused notice of a public hearing of the Agency pursuant to Section 859-a of the Act (the "Public Hearing"), to hear all persons interested in the Project and the financial assistance being contemplated by the Agency with respect to the Project, to be mailed on November 19, 2015 to the chief executive officers of the county and of each city, town, village and school district in which the Project is to be located, (B) caused notice of the Public Hearing to be published on November 20, 2015 in the Press and Sun Bulletin, a newspaper of general circulation available to residents of the City of Binghamton, (C) conducted the Public Hearing on December 3, 2015 at 12:00 o'clock p.m., local time, at the Broome County Public Library in the City of Binghamton, Broome County, New York, and (D) prepared a report of the Public Hearing (the "Report") which fairly summarized the views

presented at said Public Hearing and distributed same to the members of the Agency; and

WHEREAS, on April 6, 2016, the City Council of the City of Binghamton adopted a resolution in support of a Payment-In-Lieu-Of-Tax Agreement (“PILOT Agreement”) deviating from the Agency’s uniform tax-exemption policy. A copy of the approved PILOT payment schedule is attached hereto as Exhibit “A”; and

WHEREAS, in order to complete the documentation necessary to consummate the aforesaid Project described in the Notice of the Public Hearing, the Agency proposes to enter into the following documents (hereinafter collectively referred to as the “Agency Documents”):

- (A) lease agreement (and a memorandum thereof) (the “Lease Agreement”) by and between the Company and the Agency, pursuant to which, among other things, the Agency acquires an interest in the Project;
- (B) leaseback agreement (and a memorandum thereof) (the “Leaseback Agreement”) by and between the Agency and the Company pursuant to which, among other things, the Company agrees to undertake and complete the Project as agent of the Agency and the Company further agrees to lease the Project from the Agency and, as rental thereof, to pay the Agency’s administrative fee relating to the Project and pay all expenses incurred by the Agency with respect to the Project; and
- (C) the Payment-In-Lieu-Of-Tax Agreement (the “PILOT Agreement”) by and among the Company and the Agency, pursuant to which the Company agrees to make payments in lieu of taxes with respect to the Project; and (C) various certificates relating to the Project (the “Closing Documents”).
- (D) Agency Agreement authorizing the Company to act as the agent of the Agency for the purpose of the renovation and equipping of the Project; and
- (E) all other documents necessary to effect this transaction.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF BROOME COUNTY INDUSTRIAL DEVELOPMENT AGENCY, AS FOLLOWS:

Section 1. The Agency hereby finds and determines that:

(A) By virtue of the Act, the Agency has been vested with all powers necessary and convenient to carry out and effectuate the purposes and provisions of the Act and to exercise all powers granted to it under the Act; and

(B) The Project constitutes a “project”, as such term is defined in the Act; and

(C) The renovation and equipping of the Project and the leaseback of the Project to the Company will promote and maintain the job opportunities, general prosperity and economic welfare of the citizens of Broome County, New York and the State of New York and improve their standard of living; and

(D) Having reviewed the Report of the Public Hearing and having fully considered all comments contained therein, the Agency hereby further determines that it is desirable and in the public interest for the Agency to proceed with the Project and enter into the Agency Documents.

Section 2. In consequence of the foregoing, the Agency hereby determines to: (A) proceed with the Project; (B) acquire by lease the Land, the Facility and all other improvements now or hereafter located on the Land (collectively, the "Project") from the Company; (C) renovate and equip the Project, or cause the Project to be renovated and equipped; (D) leaseback the Project to the Company pursuant to a Leaseback Agreement between the Agency and the Company pursuant to which, among other things, the Company shall be obligated (1) to pay all costs incurred by the Agency with respect to the Project, including all costs of operation and maintenance, all taxes and other governmental charges, any required payments in lieu of taxes, and the reasonable fees and expenses incurred by the Agency with respect to or in connection with the Project, and (2) to comply with the provisions of the Act applicable to beneficiaries of financial assistance from the Agency; and (E) enter into the Payment-in-Lieu-of-Tax Agreement.

Section 3. The Agency is hereby authorized to acquire (A) a leasehold interest in the Project pursuant to a lease agreement (the "Lease to Agency") from the Company to the Agency and (B) title to the Equipment pursuant to a bill of sale (the "Bill of Sale to Agency") from the Company to the Agency and to do all things necessary or appropriate for the accomplishment thereof, and all acts heretofore taken by the Agency with respect to such acquisitions are hereby approved, ratified and confirmed.

Section 4. The Agency hereby authorizes the Company to act as its agent with respect to the renovation and equipping of the Project and to do all things necessary or appropriate for the accomplishment thereof.

Section 5. The City Council of the City of Binghamton has adopted a resolution encouraging the Agency to deviate from its uniform tax exemption policy in the manner set forth in the attached PILOT Agreement, and the Agency has determined that such deviation will assist the Company in the development of the Project which will provide a significant economic impact on the City of Binghamton and County of Broome.

Section 6. The form and substance of the Agency Documents (in substantially the forms presented to this meeting) are hereby approved.

Section 7. (A) The Chairman, Vice Chairman, Secretary, or Executive Director of the Agency are hereby authorized, on behalf of the Agency, to execute and deliver the Agency Documents and, where appropriate, the Secretary of the Agency is hereby authorized to affix the seal of the Agency thereto and to attest the same, all in substantially the forms thereof presented to this meeting, with such changes, variations, omissions and insertions thereto as the Chairman, Vice Chairman, Secretary, or Executive Director shall approve, the execution thereof by the Chairman, Vice Chairman, Secretary, or Executive Director to constitute conclusive evidence of such approval.

(B) The Chairman, Vice Chairman, Secretary, or Executive Director of the Agency are hereby further authorized, on behalf of the Agency, to designate any additional Authorized Representatives of the Agency (as defined in and pursuant to the Lease Agreement).

Section 8. The officers, employees and agents of the Agency are hereby authorized and directed for, and in the name and on behalf of the Agency, to do all acts and things required or provided for by the provisions of the Agency Documents, and to execute and deliver all such additional certificates, instruments and documents, to pay all such fees, charges and expenses and to do all such further acts and things as may be necessary or, in the opinion of the officer, employee or agent acting, desirable and proper to effect the purposes of the foregoing Resolution

and to cause compliance by the Agency with all of the terms, covenants and provisions of the Agency Documents binding upon the Agency.

Section 9. This Resolution shall take effect immediately.


