RESOLUTION ACCEPTING A REVISED APPLICATION FROM BLUESTONE WIND, LLC, OR ITS DESIGNEE, (THE "COMPANY") FOR A LEASE/ LEASEBACK TRANSACTION TO FACILITATE THE FINANCING OF THE ACQUISITION, CONSTRUCTION, INSTALLATION AND EQUIPPING OF A WIND-POWERED ELECTRIC GENERATING FACILITY LOCATED ON THE COMPANY'S FEE, LEASEHOLD AND EASEMENT INTERESTS IN PARCELS OF LAND LOCATED IN THE TOWNS OF SANFORD AND WINDSOR, BROOME COUNTY, NEW YORK, TO PROVIDE FOR A SALES AND USE TAX EXEMPTION BENEFIT IN AN AMOUNT NOT TO EXCEED \$8,807,628.00, TO PROVIDE A MORTGAGE TAX EXEMPTION IN AN AMOUNT NOT TO EXCEED \$1,918,038.00, AND A REAL PROPERTY TAX EXEMPTION IN AN AMOUNT NOT TO EXCEED \$14,577,103.00, INCLUDING A DEVIATION FROM THE AGENCY'S UNIFORM TAX EXEMPTION POLICY, AND AUTHORIZING THE AGENCY TO SET AND CONDUCT A PUBLIC HEARING WITH RESPECT THERETO.

This Resolution shall take effect immediately.


