Agenda Item 4: 2022 Budget. Ms. Duncan stated that the Proposed BCLDC Budget includes the continuation of annual income derived from grants and annual project payments. The BCLDC is the tool used to conduit debt through tax-exempt bond financing. Most notably, through the UHS Bond issued in 2019, the BCLDC has taken a conservative, but realistic approach toward income projects and expenditures. Ms. Duncan then went through the budget, line-by-line. A short discussion followed. MOTION: To Recommend Approval of the 2022 BCLDC Budget. On a MOTION by Mr. Mirabito, seconded by Mr. Rose, the MOTION CARRIED.
