ITEM \#1. APPROVE THE MINUTES FOR THE NOVEMBER 29, 2023 MEETING: Chairman Crocker stated that the minutes were forwarded to all members; they had an opportunity to review any modifications were forwarded. Chairman Crocker accepted the minutes for the record.

ITEM \#4. REVIEW AND RECOMMENDATION OF THE READOPTION OF THE AGENCY'S INVESTMENT AND DEPOSIT POLICY, INTERNAL CONTROLS AND FINANCIAL ACCOUNTABILITY POLICY, THE PURCHASING POLICY, THE PROPERTY ACQUISITION GUIDELINES, AND THE PROPERTY DISPOSITION GUIDELINES WITH NO CHANGES. Ms. Abbadessa stated that this is an annual requirement of the Authority's Budget Office that The Agency review its financial policies every year and either modify those policies or recommend that they be reapproved for the following year as is. ITEM \#5. REVIEW AND RECOMMENDATION AUTHORIZING THE EXECUTIVE DIRECTOR TO REQUEST AMERICAN RESCUE PLAN FUNDS IN THE AMOUNT OF \$500,000.00 FROM BROOME COUNTY FOR THE PURPOSE OF SUPPORTING SMALL BUSINESS DEVELOPMENT TO ADVANCE THE INTERESTS OF THE CITIZENS OF BROOME COUNTY. Ms. Duncan stated this is a continued partnership with Broome County. This is a grant program to provide a one-time grant for small businesses with operational and other eligible costs. The grant will prioritize businesses that are outside of our urban core communities, but others are not precluded from applying. Guidelines for the grant program are be finalized now with Broome County.
